Boise State University is "The New U Rising," with new buildings, record enrollment, new academic offerings and cutting-edge research. These elements all combine to create a thriving, engaged campus community of almost 20,000 students — the largest enrollment in the Gem State.

Boise State's location in the center of Idaho's commercial, cultural and civic capital and its emerging role as a metropolitan research university of distinction play a crucial and growing part in the region's economic development and famed quality of life. Its nearly 200 academic programs and ever-expanding master plan for the 183-acre campus and its 175 buildings are helping it better serve its students and the community at large.

The university is currently in the midst of its first-ever comprehensive campaign to raise \$175 million to strengthen its people, places and programs. "Destination Distinction: The Campaign for Boise State University" will bolster Boise State's current reputation as an excellent undergraduate teaching university while also helping it advance as a research university.

University milestones during his tenure include the creation of the President's Civic Leadership and Boise State Capital Scholars programs, recording-setting years in total funds for research and sponsored programs, and the completion of several new academic, residential and athletic facilities. Dr. Kustra also serves on the NCAA's highest governing body as a member of the Division I executive committee and board of directors.
