## Proposed BSC Constitution

In order to insure adequate student representation in associated student government as we become Boise State College, the following constitution has been drawn up by a student constitutional revision committee and approved by the executive council.

It is suggested that students take this opportunity to read this proposed constitution and be familiar with it in order to exercise their vote of ratification on general election day, March 1.

### ASSOCIATED STUDENT BODY OF BOISE STATE COLLEGE PROPOSED CONSTITUTION

#### ARTICLE I

##### Associated Student Body of Boise State College (ASBSC)

Sec. I. Name. The name of this organization shall be the Associated Student Body of Boise State College.

Sec. II. Membership. Any student of Boise State College, upon payment of the required fees to the Vice President of Financial Affairs, shall be a member of this association.

Sec. III. Purpose. The purpose of this association shall be to represent the students of Boise State College, to administer and execute the affairs of the Associated Students of Boise State College.

Sec. IV. Authority. This association shall operate within the standards set forth by the State Board of Education and administered by the delegated authorities of Boise State College. The Dean of Student Personnel Services, or his representative, is the official representative of the College and shall act as advisor to this association.

Sec. V. Operation. This association shall operate according to Robert's Rules of Order unless otherwise specified.

#### ARTICLE II

##### Executive Council

Sec. I. Membership. The Associated Student Body President, Vice President, Secretary and Treasurer; the four class presidents and two representatives from each class; and the two representatives from the Student Senate shall constitute the membership of this council. The President shall vote only in case of a tie.

Sec. II. Advisor. The Dean of Student Personnel Services shall be an ex-officio member.

##### Sec. III. Duties.

Clause 1. Formulation of student policy.

Clause 2. Carry out administrative matters of the ASBSC.

Clause 3. To implement the programs and projects of ASBSC and supervise the various committees.

Clause 4. To meet weekly or at the discretion of the Executive Council.

Clause 5. To approve by a 2/3 vote all executive appointments.

Clause 6. To approve by a 2/3 vote to fill any vacancies on the Executive Council other than the president.

Clause 7. To approve by a 2/3 vote the budget recommended by the ASBSC Treasurer.

Clause 8. To file individual reports of their work at the conclusion of their terms of office.

Clause 9. To initiate action by 2/3 vote to remove an Executive Council member who is unwilling or unable to carry out his duties, and then submit this action with accompanying ballots to the ASBSC Senate. A 2/3 vote of the Senate will be required for removal of Executive Council members.

Clause 10. To create necessary committees.

Clause 11. To determine one member of the Judicial Committee.

Clause 12. To act as representatives of the Associated Students of Boise State College.

Sec. IV. Eligibility.

Clause 1. To be eligible for any class office or student body office, a cumulative 2.25 must be achieved to run for office and a 2.0 must be maintained for the duration of office. To be eligible for a student body office, a candidate must have completed 60 credits. The minimum requirements for class officers shall be: 30 credits for sophomore officers, 60 credits for junior officers, and 90 credits for senior officers. Freshman candidates shall be required to have a 2.5 cumulative or the equivalent from high school.

Clause 2. The treasurer, in addition to meeting the other requirements, must be a business major.

Sec. V. Inauguration.

Clause 1. Newly elected officers shall be sworn in at the first Executive Council meeting following the elections.

Clause 2. The following oath shall be used in the swearing in of officers, administered by the President: "I do solemnly affirm that as a member of the Executive Council (or, as President, Vice President, Secretary or Treasurer of the Associated Student Body of Boise State College), I will faithfully and to the best of my ability perform all the duties of my office and that I will promote the best interests of Boise State College."

## BC's FIRST REAL 'LITTLE THEATER' TO BE COMPLETED AS PART OF RENOVATION OF OLD STUDENT UNION BUILDING

At a cost of \$33,000, the ballroom of the old Student Union building is being turned into BC's first "little theater" since the college was founded in 1932.

Dwane Kern, BC's business manager, placed the total cost of renovating the old SUB into the theater and the annex for the music, speech, and drama departments at \$48,000. He said the firm of Hummel, Hummel, Jones and Shawver had done the architectural work on the building.

The theater, which Robert Dewey, speech and drama instructor, termed, "Probably one of the most original in Idaho," will be the first complete facility the speech and drama department has had on campus.

For the last three years the department has held its plays on the second floor of the library building in what is now the periodical department. Before the library was built, however, the department presented its efforts in the music auditorium and before that, the T-1 building saw the plays held in it.

In addition to the second floor, "little theater" contractors are presently remodeling the first floor of the old SUB. The ground level will now serve as classrooms and music practice rooms. Presently,

the cafeteria remains untouched. The entranceway will serve as the foyer of the theater.

"The theater itself," John E. Warwick, acting chairman of the drama and speech department, reiterated, "will be the first real theater the college has had."

The theater will have a capacity of 130 persons. The audience will be surrounded by deep-blue painted walls, while they watch the plays from real theater seats, which have been placed on a raised level, somewhat like a stadium-bleacher set-up. The stage was constructed with a combination of ideas in mind. It is modeled after the stage in Stratford, Ont., with certain renovations conceived by Warwick. It consists of a "thrust" platform 24 ft. wide and 16 ft. deep, with a balcony located seven feet above it. There are two staircases leading from the balcony to the platform on the right and left of the stage. The entire performance area is painted black.

Situated behind the stage is a prop shop, with a ten-foot opening under the balcony for quick placement or removal of scenery by the stage hands.

At the other end of the theater, two small rooms have been partitioned off. They will serve as storage areas and costuming shops.

Below the prop shop, on the first floor of the building the contractors have installed dressing rooms with all the necessary facilities.

The foyer to the theater will be completely carpeted, and a gold-paint staircase, also carpeted, will take the theater goer to the second floor. The dark blue painted stairwell will also serve as a sort of art gallery.

Completion of the theater is expected to be some time this month, with the first performance to be held in it April 18. "Midsummer Night's Dream" will be the first work presented in the new facility.

Warwick said the theater will be used daily next year, with various classes in drama and directing being held there. He added that five plays would be presented by the drama department next year. He said that with all the time and preparation that must go into each play, the theater would not be used for any other purpose.

## MARCH 1 DEADLINE FOR APPLICATIONS SET BY REGISTRAR

The deadline for making applications for graduation for the spring graduation of May 12, 1968, is March 1. After this time no further applications will be accepted for either the two-year or four-year programs.

Any student who wants to check on the status of his application should see Mrs. Alice Hatton, registrar.

Also, a reminder to all graduating students that any change in his or her course program on which graduation is based should be checked through with the registrar along with any changes in names.

At graduation, mementos in the form of a wallet-sized, plastic-encased miniatures of each student's diploma will be given out along with the original diploma itself. This is being done for the first time in the college's history and is the reason for the March 1 deadline for graduation applications.

## Luncheon Held For Boise Legislators

At a luncheon in the Boise College SUB Feb. 7, President John Barnes addressed a group of legislators.

Speaking on the development of the college, Barnes explained the need of using student building fees to bring BC up to par with other schools, since the state does not have the necessary funds to do so in the short time desired.

Dr. Barnes also explained that Boise College would not duplicate instruction provided at the other Idaho schools.

The luncheon was sponsored by the college Young Republicans, with Roundup Political Editor Ron Oliver introducing the speaker.

**Sec. VI. Absence of Officers.** Any officer of the association, upon having an excess of three unexcused absences, as determined by the Executive Council, shall be automatically impeached.

**Sec. VII. The Student Body Officers.** The Student Body Officers of this association shall be the President, the Vice President, the Secretary and the Treasurer.

Clause 1. Accorded to the ASBSC President shall be a scholarship totaling \$250.00 per semester; endowed to the ASBSC Vice President, Secretary and Treasurer shall be a scholarship totaling \$125.00 per semester.

Clause 2. As of January 1, 1969, the ASBSC Student Body Officers shall receive full tuition and fees. The President will receive in addition to this a \$100.00 credit at the bookstore per semester.

**Sec. VIII. Duties of the President.**

Clause 1. To preside over the Executive Council meetings where he shall vote only in case of a tie.

Clause 2. To serve as an ex-officio member of the Executive Council.

Clause 3. To appoint chairmen for the standing committees.

Clause 4. To fill all appointive positions.

Clause 5. He shall have the power to call special meetings of the Executive Council.

Clause 6. He shall be the official representative of the college Associated Student Body to the community, state and administration.

**Sec. IX. Duties of the Vice President.**

Clause 1. He shall preside over the Executive Council in the absence of the President.

Clause 2. He shall be a voting member of the Executive Council, and shall assist the President.

Clause 3. He shall succeed the President in the event of a vacancy in the latter office.

**Sec. X. Duties of the Secretary.**

Clause 1. Shall be a voting member of the Executive Council and shall assist the President.

Clause 2. Shall be responsible for all minutes of the Executive Council.

**Sec. XI. Duties of the Treasurer.**

Clause 1. Shall be a voting member of the Executive Council and shall assist the President.

Clause 2. All ASBSC funded organizations shall be financially responsible to the Treasurer.

Clause 3. Shall supervise all the financial transactions of the ASBSC and shall be responsible to the Executive Council for all matters pertaining to the budget and its expenditures.

Clause 4. Shall submit a proposed budget to the Executive Council for its approval.

**Sec. XII. Duties of the Class Presidents and the Class Representatives.**

Clause 1. They shall be voting members of the Executive Council and shall assist the President.

Clause 2. They shall represent their respective classes on the Executive Council.

**Sec. XIII. Duties of the Senate Representatives.**

Clause 1. They shall be voting members of the Executive Council.

Clause 2. They shall represent the Senate on the Executive Council.

### ARTICLE III

#### Student Senate

**Sec. I. Membership.**

Clause 1. The membership of this body shall be composed of one representative from each organization recognized by the Boise College Senate as of the date of acceptance of this constitution; and one representative from each organization recognized by the Senate after the above date.

Clause 2. The ASBSC President and the College President shall be ex-officio members of the Senate.

**Sec. II. Duties.**

Clause 1. The senate shall formulate by-laws to determine the operation and organization of the body.

Clause 2. They shall determine their two representatives from the Senate to the Executive Council.

Clause 3. They shall determine two members of the Judicial Committee.

Clause 4. They may propose and initiate student policy and review policy formation on the Executive Council.

Clause 5. They shall determine the membership of new organizations on the Senate.

Clause 6. They shall decide on impeachment proceedings initiated by the Executive Council.

### ARTICLE IV

#### Judicial Committee

**Sec. I. Membership.** Membership shall consist of three members; two determined by the Senate and one by the Executive Council.

Clause 1. The Judicial Committee shall have final authority on all questions of interpretation of this constitution, by-laws, and legislation.

Clause 2. To determine ASBSC election procedures and conduct ASBSC elections.

Clause 3. To preside over impeachment procedures.

### ARTICLE V

#### Elections

**Sec. I. Time.** The President, Vice President, Secretary and Treasurer shall be elected spring semester on the first Friday in March.

**Sec. II. Plurality.** A plurality is necessary for election to the Executive Council.

**Sec. III. Class Officers.** The Class Officers shall be elected in the fall semester, no later than the third week of class.

**Sec. IV. Election Policy.** Election policy and administration shall be under the jurisdiction of the Judicial Committee, including all matters pertaining to the voting and the tabulating of the results. All decisions of the Judicial Committee shall be subject to the review of the Executive Council and the Senate.

**Sec. V. Term of Office.** Term of office shall be from election to election.

**Sec. VI. Ballot System.** The secret ballot (Australian Ballot System) shall be used in all elections of this association.

### ARTICLE VI

#### Funded Organizations and Standing Committees

**Sec. I. Funded Organizations.**

Clause 1. Shall be financially responsible to the treasurer.

Clause 2. Must have Executive Council approved by-laws in order to receive ASBSC funds.

Clause 3. They will not have voting membership on the Senate.

**Sec. II. Standing Committees.**

Clause 1. The standing committees shall include Social Committee, Lyceum, SPIB and SPRB (Student Public Information Board and Student Public Relations Board).

Clause 2. Chairmen shall be appointed by ASBSC President with the approval of the Executive Council.

### ARTICLE VII

#### Constitutional Revision

**Sec. I. Proposition of Amendments.**

Clause 1. Amendments to this constitution may be proposed by a petition of 10 per cent of the ASBSC to the Executive Council.

Clause 2. Amendments may be brought before the Executive Council by a majority vote from the Senate.

Clause 3. Amendments may be proposed by  $\frac{1}{3}$  of the Executive Council.

**Sec. II. Adoption of Amendments.** An amendment to this constitution must be approved by a  $\frac{2}{3}$  vote of the voting membership of the Executive Council for adoption.

**Sec. III. Revision.** This constitution may be amended only in the ways specified in this article of the constitution.

**Sec. IV. Rewriting.** Any time there is a vast rewriting of this constitution, or when a new constitution is proposed, it must be approved by a general student body vote, of which a majority of the votes must be cast for the new constitution before it is adopted.

## Esquire Memorial Mall to Be Constructed Starting April 1 Between L. A. & Library

April 1 has been set as the starting date for construction of the Esquire Memorial Mall which will fill the area between the Library and Liberal Arts building, according to Larry Dresser, project coordinator.

The Mall, planned in commemoration of servicemen who have died for America, will be 192 feet long and 80 feet wide. Constructed of white concrete, the area will be equipped with floral planters, benches, a fountain, and lighting. Two large planters, 40 feet x 8 feet, two smaller planters, a planter-fountain combination, 56 feet by 40 feet, and a series of three planters leading to the Music Auditorium, each 29 feet by 8 feet, are included in the layout.

A flagpole-planter grouping will be built adjacent to the Mall. Funds for the removal of the present flagpole and the erection of

a taller pole have been provided for by the Boise Bench Lions. The combination will lie on the present Library-Ad. building walkway.

Fund Chairman Kent Averill placed estimated expenditures for construction at \$17,800.

John Poulson and Averill are co-coordinators of fund raising, and they are supported by 10 division chairmen: Dick Carr (On-campus Organizations), William Belknap (Industrial Firms), Art Aamouth (Commercial Firms), Ray Green (Legal Affairs), Tom Chatterton (Social Events), Harvey Hoskins (Civic Organizations), Dennis Barton (Military Organizations), Bob Morgan (Police Departments), Joe Bongiovi (Fire Stations), and Lewis McFarland (Athletic Departments).

Money is being raised from every source. Donations are pledged at division meetings of the college faculty with support already coming from the Biology department. The Sunshine Club, a group of campus secretaries, the Flying Club, and Chaffee Hall have promised funds to the Mall, and both the Elks Gleemen and the Basque Dancers have agreed to give joint concerts with all proceeds going to the Esquires. Plans are in progress for a sports car rally and dance. The Interservice Club Council has promised to match the faculty donations, dollar for dollar.

## \$60 BUILDING FEE BEGINS JAN. 1, '69

The Student Executive Body has voted 40-1 in favor of a \$60 student building fee for Boise College students on Jan. 17, 1968. The bill was then passed Jan. 18 by the executive officers.

The building fee will aid in covering the future increased building expansion costs and will be effective as of Jan. 1, 1969.

Although the fee increase is \$60, there will be no in-state tuition as of Jan. 1, 1969.

The College Board of Trustees made the original proposal of a building fee to the Student Executive Board.

## The Score Is . . .

Various people have, through the years, indicated that one should not voice opinions on subjects he knows nothing about. If, therefore, one wished to be technical and use a strict definition of knowledge, he would never need to open his mouth except to eat (and he might as well keep it closed then).

They are too conservative, too afraid to voice themselves in any way, too incompetent to organize themselves into effective units of experience-knowledge obtaining intellects.

Instead, they haven't the time. Classes, studies, and families take up all their time—except for that reserved for Joe's Bar. The fact is that they do indeed have the time and, furthermore, cannot afford not to use it. It is absurd to say you haven't time to devote to the development of Boise College, especially when you can contribute immensely to the improvement and growth of number one.

This critic himself has been in the apathetic crowd, but even a mediocre reflection revealed that I was wasting a lot of time.

Professor C. Griffith Bratt will complete the two and one-half year series of the complete organ works of Bach this coming Sunday at St. Michael's Cathedral on 8th and State Streets at 5 p.m. The public as well as interested Boise College students, is invited to attend.

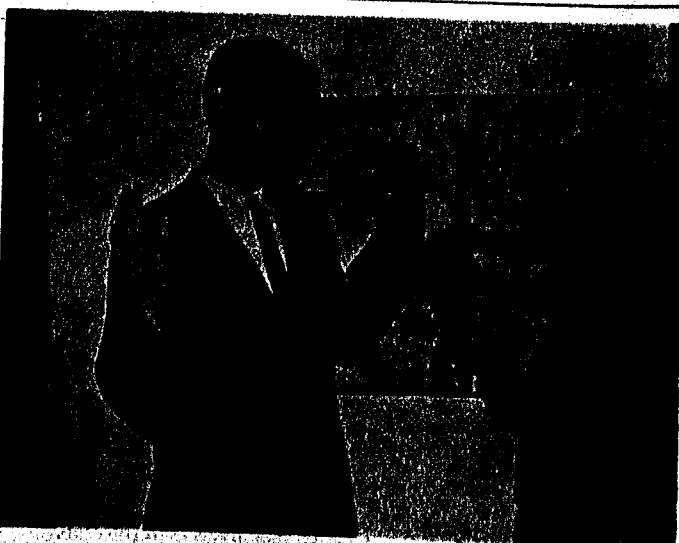

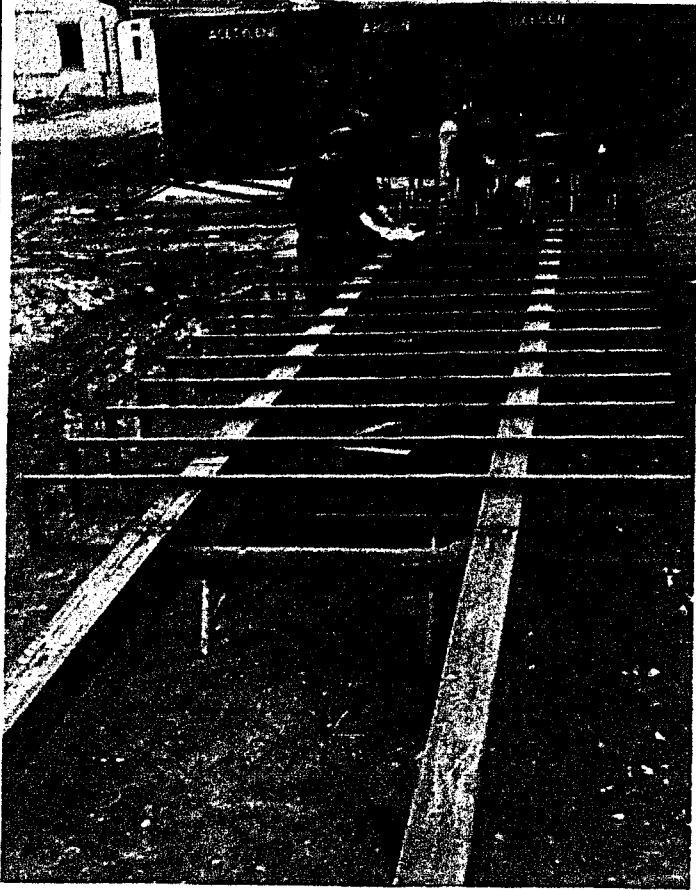


## Campaigning Begins Feb. 26 for Offices OF ASB Government

Elections for student body offices of president, vice president, secretary, and treasurer will be held March 1. Along with these the new constitution will be up for ratification.

All candidates for offices must have a cumulative 2.0 GPA and be on upper division student by next fall, having 60 or more credit hours. The president is entitled to a \$250 scholarship per semester and the other officers will receive a \$125 scholarship per semester.

Candidates may pick up petitions in Room A108. They must be returned by 4:00 p.m., Feb. 21. Campaigning will begin Feb. 26 and the election will be held Mar. 1. Polls will be open 9 until 3 p.m. in the SUB and the Library.

## VALKYRIE SIGN REACHES FIRST STEP IN ROUTE TO EVENTUAL ERECTION

The new Capitol Boulevard Boise College sign and marquee is reaching the first stage of completion by the Voc-Tech welding class. The class is fabricating the metal framework, which will be faced by red brick, according to the specifications of Signs, Inc.

The framework of the sign is 36 feet long, constructed mainly

of 10-inch I-beams and smaller angle iron. Upon completion, the sub-structure will weigh approximately 2,600 lbs.

According to Instructor John T. Ogden, the most difficult part of the structure is the internal tubing which contains the wiring for the lighted portion of the sign. This tubing must come through the brick at exactly the right point behind the letters so that the wiring may travel from one letter to another. The frame is the largest structure ever attempted by the welding shop. Also scheduled to be built by the Voc-Tech shop are the large Bronco mascots that will grace both sides of the pylon.

Members of the welding class working on the project are sophomores Gale Bosworth, Ron Bedke, and Victor Morris. The marquee project is sponsored by the Valkyries and being built by Tau Alpha Pi.

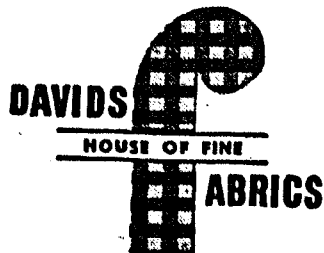
### 'MOUSE' TO ROAR

Need something terse and "insightful" to jazz up that sagging term paper or report? If you haven't already discovered this little gold mine, "drag your bod" over to the library and start burrowing through the pamphlet file. Whatever subject you hope to expound upon, you should find something pertinent. Newsletters and leaflets arrive daily dealing with anything from Arabs to zucchinis.

For sociology studies there are monthly publications from the poverty front, such as "Rural Opportunities" and "Community Action," and masses of material on drugs, employment and the status of women. Finding current material about Idaho and Boise may be difficult elsewhere, but in the pamphlet file are several Boise topics, including urban renewal. Idaho is well represented, with information ranging from education to taxation.

Across the aisle is the U. S. government document file. Remember those little gems you sent for when you were in junior high? Here again is a helpful source of valuable in-depth information, includ-

ing the latest geological survey reports, government research reports, vital statistics, cancer and heart disease reports and statistics, and Supreme Court decisions (since 1966). Other booklets deal with the world food crisis, foreign and domestic economic development, labor, conservation, and problems of the aging.

If it is the future that concerns you, there is a file listing career information about everything from "Able Seamen" to "Zoologists," plus the current "occupational outlook" for many fields. Also in this section are guidance and counseling aids, with suggestions for personal improvement, how to prepare for a job interview, and how to put your best foot forward at the start of your career.

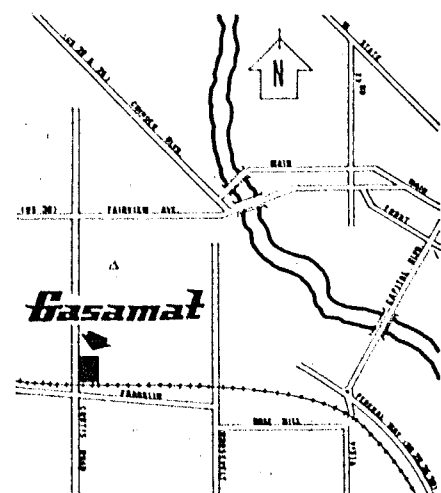

## Broncos Win ICAC Title; Mesa, Weber And TVCC Wipeout

The Boise College Broncos sewed up the ICAC net title Saturday night by defeating Mesa College 81-57. Offensively the BC quint started off a little slow but before many minutes had elapsed they were back in great form, netting a basket nearly every time they were in possession of the ball. Defense was the Broncos' big asset as time and time again they bottled up Mesa and forced them to give up the ball on technical errors or rushed shots.

From the first minute to the last, BC dominated the ball game. At one point early in the contest BC led by 21 to 9, and by halftime they had the same 12-point lead, 33-21. The second half the Broncos completely dominated the court again and ended up the victors, 81-57.

High scorers for the Broncos were Hart with 26 points, Hill 19, Otey 16 and Ron Austin added 11. Mesa's leading scorers were John Nielson with 12 and Norbert Bedow with 11.

### TVCC

Fighting off a desperate closing period rally by TVCC, the Boise College Broncos posted their 21st win of the season Feb. 8, by handing the Chukars a 75-70 setback on the Ontario High court.

Things started slowly with the Chukars feeling out the Broncos, and the Broncos feeling out the strange court. With 10 minutes gone in the opening half, the score was 13-all.

Ronnie Austin then hit six quick points in three minutes and Boise surged into the lead 27-16, and increased it to 37-29 at the half. In the second half it was all Boise until Chukars Mike Moore and Les Harris caused turn-overs and scored 10 points, while the Broncos managed but two.

Otey led the Boise scoring with 22, Austin garnered 20, Hart 16, and Keith Burke chipped in 10. Harris paced Treasure Valley with 33 and Moore backed him up with 15.

Otey grabbed off 18 rebounds and Austin added 12 to lead the Broncos to a 46-32 advantage. Walt Buck let the Chukars with 11. From the field, Boise hit 30 of 69 attempts and added 15 of 21 from the charity stripe. TVCC hit 29 of 78 from the floor, and 12-16 at the line.

### WEBER STATE FROSH

Headed by Wendy Hart's 19-point first half, the BC Broncos pulled off a 73-66 win over the Weber State freshman team at the BC fieldhouse.

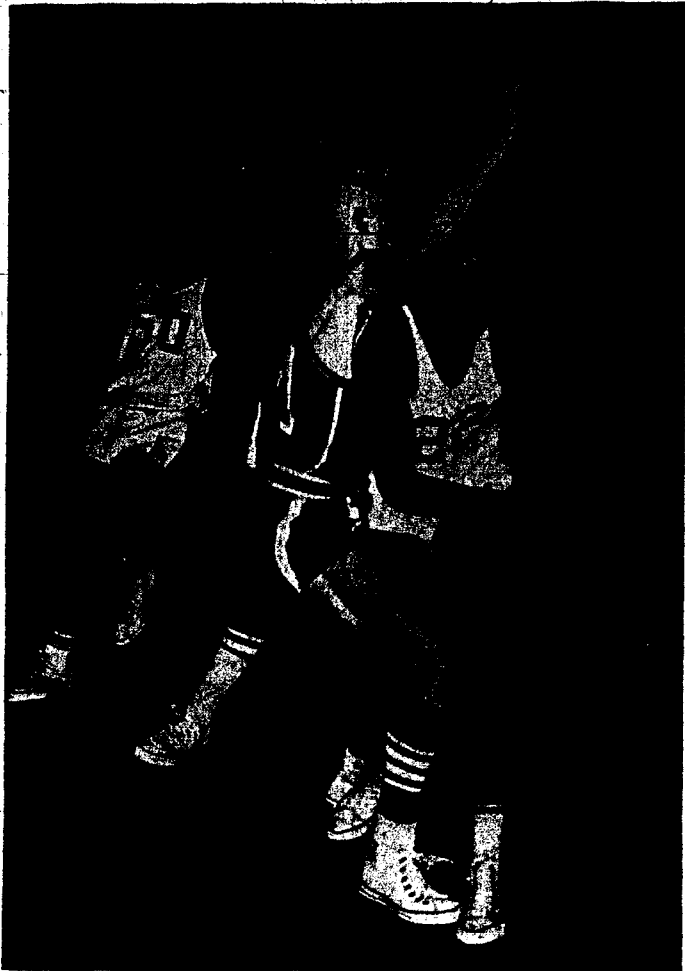
In addition to Hart's hot shooting, Ronnie Austin lent a hand to the Bronco cause with his valuable back court play. With Keith Burke and Bill Otey in foul trouble during the second half, the Weber State cagers came from 10 points back to trail the Broncos, 55-54.

But Don Cox's free throws with slightly more than seven minutes remaining gave Boise some breathing room, and after Otey had retired on fouls, Coach Satterfield calmed down the anxious Broncos, and Burke and Austin got them moving again.

Four players hit the double scoring figures for each team, with Hart leading the Bronco charge with 23. Dave Sackolwitz paced the Wildcats with 17 points, while Otey and Burke did a fine job in holding high-scoring Willie Sojourner to a mere six points.

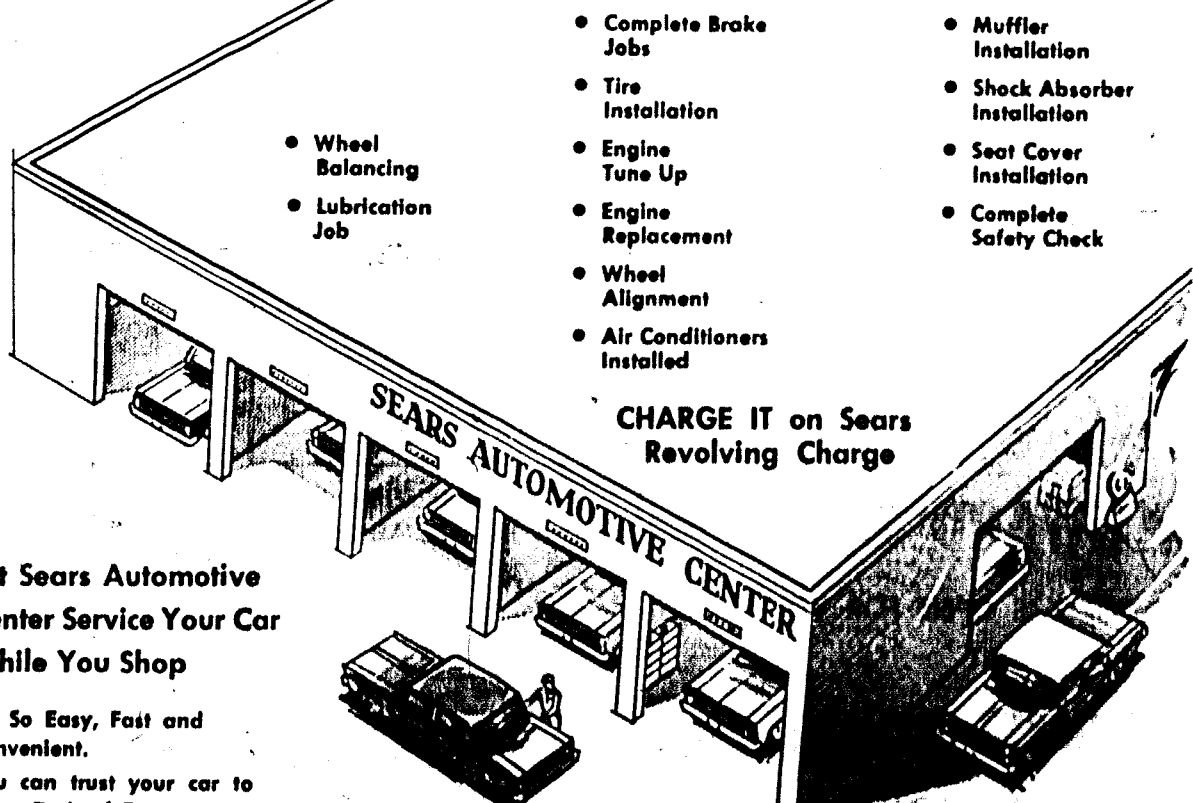
