I think emotionally, this audience will find this project very interesting and beneficial for the ranching community in Harney County.

My research is valuable to others because I plan on sharing it to the community. They will find lots of information as well as answers to their questions about the different types of weeds that cause havoc on their ranches. This information will be valuable, because it will hopefully keep them aware of what kinds of weeds to watch out for, as well as the different kinds of weeds that cause harm to livestock eating and living around them.
