

## BSU CLASSIFIED LEAVE POLICIES

BSU 5520-C Effect. Date: July 1, 1995

#### J. Organization Participation and Exercise Leave

Boise State University employees will be permitted a total of one hour per month release time from work to attend professional representative organization meetings. The organizations include:

ACE - Association of Classified Employees; BSU-AOP - Boise State University Association of Office Personnel; PSU-IPFA - Poice

BSU-IPEA - Boise State Chapter, Idaho Public Employee's Association.

- 1. Employees who are officers in one of the above organizations, will be permitted a total of two (2) hours per month release time to organize and conduct the business of the organization's).
- 2. The employee must have supervisory approval prior to taking the release time to avoid conflict with the efficient and effective operation of University business.
- 3. Other organizations desiring approval for release time should submit written requests to the Department of Human Resources, outlining the goals and purposes of the organization for review by the appointing authority.
- 4. Questions regarding a typical leave situation not clarified in this policy should be referred to the Department of Human Resources.

## STUDENT SCHOLARSHIP OPPORTUNITY OFFERED BY ADA COUNTY ASSOCIATION

Scholarship applications are being accepted by the Ada County Association of Educational Office Professionals. This scholarship is designed to assist students who wish to continue their education in a business-related career, preferably in the educational field. The scholarship is valued at \$1,000.

#### Requirements are:

- · A member of ACAEOP must sponsor candidates.
- May be a graduating high school student who has made application to continue his/her education, or may be currently pursuing such a course of study.
- · Applicant will be responsible for completing all required forms and returning them to the ACAEOP scholarship chairperson by February 23, 2004.

#### Eligibility:

- Candidates must have completed two (2) or more business education courses (four (4) semesters).
- Shall be enrolled/expect to be enrolled as a full-time student in a post-secondary institution or higher education (two or four year college, university, and business college or vocational/technical school).
- Student must maintain a 2.8 GPA (4.0 scale) for the one year period of the scholarship.


