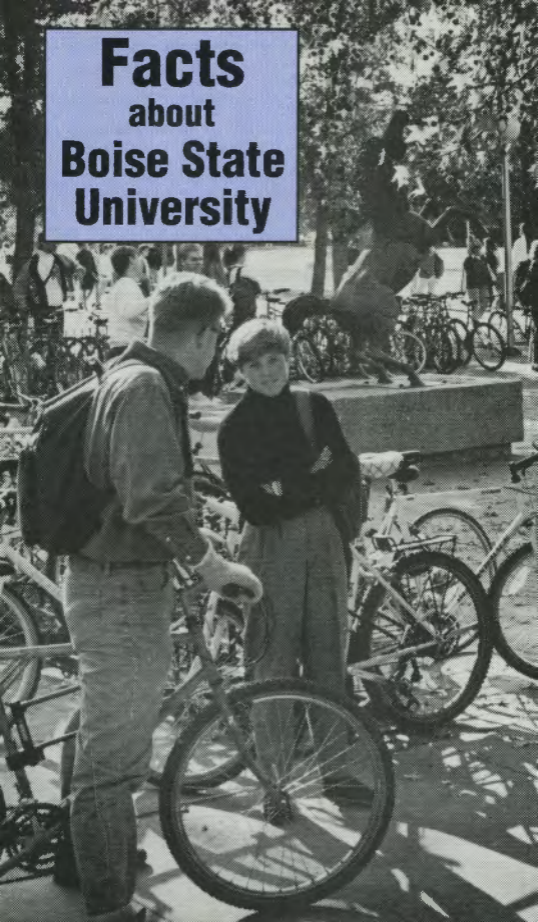


Facts about **Boise State University**



Boise State University

Boise State is Idaho's urban university, located in the state's population center and capital city, a hub of government and law, business and finance, the arts, health care, industry and technology. The university offers a variety of undergraduate, graduate and technical programs to serve the diverse needs of the area.

In addition to its main campus located less than one mile from downtown Boise, the university operates education centers in Canyon County, McCall, Mountain Home Air Force Base and Gowen Field.

The university has an extensive evening program at both the undergraduate and graduate levels, and the summer session is the state's largest.

Boise State is accredited by the Northwest Association of Schools and Colleges. Several individual programs are accredited by professional accrediting associations.

Through all of its programs, BSU is fulfilling its commitment to the citizens of Idaho by providing quality teaching, research and public service.

UNIVERSITY HISTORY

- 1932 — Boise Junior College founded by Episcopal Church.
- 1934 — BJC governed by board of directors after Episcopal Church ends affiliation.
- 1941 — Campus moved from original location at St. Margaret's Hall to present site.
- 1965 — BJC offered baccalaureate degrees and became Boise College.
- 1967 — School moved to state system of higher education and named Boise State College.
- 1974 — BSC named Boise State University.

FACILITIES

The university is located on a 110-acre campus that includes 60 buildings. BSU facilities include the Special Events Center (capacity 435), the Grace Jordan Grand Ballroom in the Student Union (1,000), Bronco Stadium (23,000), Pavilion (12,000), Morrison Center (2,000) and Centennial Amphitheatre (800).

Boise State has several off-campus facilities:

- A satellite campus at 2407 Caldwell Boulevard in Nampa, where a variety of applied technology programs and continuing education courses are offered.
- A six-court tennis complex and horticulture greenhouse just east of campus.
- A wastewater treatment program training facility in Meridian.
- A field station near Donnelly.

OUTREACH

BSU serves approximately 29,000 people annually through workshops, seminars, short courses, apprenticeship training and other non-credit programs. Some of the units responsible for outreach education include the Adult Learning Center, Center for New Directions, Center for Management Development, Small Business and Economic Development Center and Idaho Council on Economic Education.

Approximately 750,000 people attend cultural and entertainment events on campus annually. An additional 220,000 people attend athletic events.
