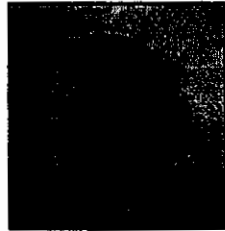

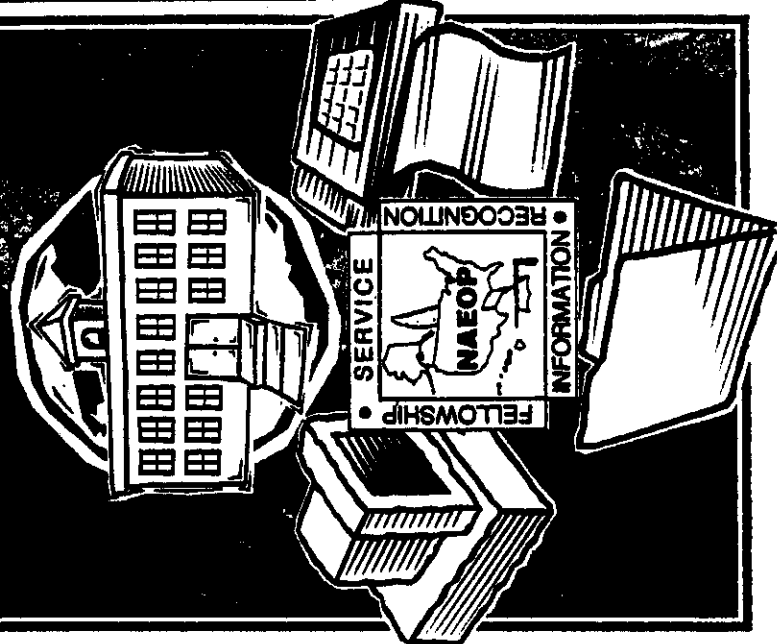

What The NAEOP Conference Was Like by Valencia Garrett

Jackie Fuller, Merrylea Hiemstra, Guen Johnson, Angela Garcia, Cathy Hampton, and Valencia Garrett attended a week-long national institute and conference of the National Association of Educational Office Professionals (NAEOP) in Chicago, Illinois with over 600 other educational office personnel. The Illinois Association of Educational Office Professionals hosted the 63rd annual conference at the Arlington Park Hilton and Conference Center on July 13-19, 1997.

The first two days consisted of institute classes. Workshops and seminars featuring nationally-known pre-

senters were part of the program which were designed for all areas of educational office responsibilities.

The balance of the conference focused on job-alike networking, NAEOP-conducted workshops called "briefings", and meetings. The opening of the general session featured a dramatic flag presentation of each U.S. state flag. The conference closed with the installation of the 1997-98 officers and board of directors.

NAEOP is the only national association for educational office personnel. The organization is dedicated to providing professional growth opportunities for its members

and continues to work toward increased recognition for educational staff members as partners on the educational team.

NAEOP recognizes the unique role of educational office professionals and the important contributions they make to the profession. The prestige, status, and credibility of NAEOP is enhanced by its affiliation with the American Association of School Administrators, National Association of Elementary School Principals, and the National Association of Secondary School Principals.
